TO ALL PROSPECTIVE BIDDERS:

The following addendum is hereby made a part of the Specifications for the above-entitled project, as fully and completely as if the same were set forth therein.

The intent of this Addendum No. 1 is to clarify the information presented in the Notice of Inviting Bids and in the Specifications regarding the bid submission and bid opening as follows:

ELECTRONIC FORMAT RECEIPT AND OPENING OF BIDS: Bids will be received in electronic format EXCLUSIVELY at the City of El Monte's electronic bidding site pursuant to Public Contract Code Section 1600 and 1601.

BIDS REMAIN SEALED UNTIL DUE DATE AND TIME. Electronic bids are transmitted into the City's bidding system via hypertext transfer protocol secure (https). Bids submitted prior to the Due Date and Time are not available for review by anyone other than the submitter, who will have until the Due Date and Time to change, rescind or retrieve its bid should they desire to do so. Upon the bidder's entry of their bid, the system will ensure that all required fields are entered. The system will not accept a bid for which any required information is missing. This includes all necessary pricing, subcontractor listing(s) and any other essential documentation and supporting materials and forms requested or contained in these solicitation documents. All bid submission information must be fully transferred from the vendors server to the bid system server before bid closing. Bids still transmitting at the time of bid closing will not be accepted.

OPENING OF BIDS. Bids will be received by the City via the electronic submission up to the date and time shown in the Notice of Inviting Bids. The City will be responsible for bid tabulations. Bids will be opened at the City Clerk's Office at the date and time stated in the Notice of Inviting Bids. Bid results will be made available to the public on the City's website in the electronic bid management system once the bid tabulation has been completed. The foregoing notwithstanding, the award of any contract shall be subject to approval by the City Council at a duly noticed City Council meeting and the City Council reserves the right to reject all bids.
